



# **10<sup>th</sup> JOINT CALL FOR PROPOSALS** **by** **The Scientific and Technological Research Council of Türkiye** **and** **The Slovak Academy of Sciences**

**The Call is open between 2 June 2025 and 22 August 2025**

## **1. Preamble**

In the framework of the Agreement on Scientific and Technological Co-operation between The Scientific and Technological Research Council of Türkiye (TÜBİTAK) and The Slovak Academy of Sciences (SAS) followed by the respective Executive Programme, Turkish and Slovak researchers are invited to submit joint proposals for research and development projects.

## **2. Objectives and the Scope of the Call**

The aim of the call is to allow partners to collaborate internationally, and gain access to new research environments, facilities, knowledge and expertise, in order to enhance the quality of their research and enable them to translate research and innovation into economic and societal benefit. Expected proposals should be tackling basic or applied research.

## **3. Thematic Areas**

Project proposals should address the thematic areas below:

- Biomedicine and Pharmaceuticals
- Plant Science and Biodiversity
- Artificial Intelligence and Its Applications
- Advanced Materials (including Biomaterials and Polymers)

## 4. Funding Available

Turkish partners that are eligible for funding can receive up to 3.000.000 Turkish Liras (excl. overhead and project incentive premium (PIP)) per project. The Slovak partners that are eligible for funding can receive up to 120.000 EURO per project per 36 months duration.

TÜBİTAK-funded costs of each grant will be issued and managed by TÜBİTAK in accordance with the rules of TÜBİTAK 1071 Programme. Detailed information can be achieved [here](#).

Similarly, SAS-funded costs of each grant will be issued and managed by SAS according to its funding guidelines and procedures.

For the bilateral visits, the Sending Party will meet all related costs of international travel.

Please liaise closely with prospective partners to ensure that both TÜBİTAK and SAS supported elements of the proposal abide by all regulations for both funders.

## 5. Duration of the Projects

The duration of the projects is **24 or 36 months**. The total duration of international visits for bilateral cooperation from one direction to another should not exceed 60 days per year.

## 6. Eligibility, Submission and Ethics

### 6.1. Eligibility

It is a prerequisite that projects include the participation of at least one Slovak SAS research institute and one Turkish institution eligible for TÜBİTAK.

### 6.2. Proposal Submission

The partners should agree with each other using their own means of communication and jointly develop and complete their project proposal before submission. TÜBİTAK and SAS do not match the collaborating partners.

Project proposals must provide detailed information on the objectives and justification of the planned joint research work, the methodology to be followed, the composition of each research team and the intended time schedule.

Turkish and Slovak researchers will prepare one joint project proposal (Application Form). The identical Application Form document must be uploaded to the respective electronic platform.

#### **For the Turkish side**

Turkish partner submits the application form to TÜBİTAK via the application system (UIDB-PBS)

accessible at <https://uidb-pbs.tubitak.gov.tr/>. The information concerning supporting documents requested from TÜBİTAK applicants is accessible at the application system. Turkish applicants are expected to submit the online application by 22 August 2025 and sign the e-signatures of relevant documents by **29 August 2025**, otherwise they will be rejected from evaluation and could not apply to this call in the same call period.

#### **For the Slovak side**

Slovak partner submits the application form and required supporting documents in the online platform set in SAS Intranet by **22 August 2025**. For further information and instructions see the document templates and manuals attached to the call announcement.

### **6.3 Ethics**

Should SAS applicants identify any ethical issues in project proposal, institute ethics committee will evaluate the issue(s) respectively. Ethics committee approval should be attached to the project proposal, if applicable.

Turkish applicants should refer to the Ethics Committee Approval Document, Legal Permission Document and Research and Intellectual Property Right Ownership Protocol available [here](#).

## **7. The Evaluation Procedure and Criteria**

TÜBİTAK and SAS follow their own parallel evaluation procedures. Only projects eligible on both sides will be evaluated. Projects that are submitted online but that did not submit requested supporting documents or e-signature(s) will not be evaluated and thus not considered for funding.

Based on own evaluation outcomes, each funding institution will prepare its own ranking list of proposals with the average score given to each proposal.

Specifically, at the SAS side, 2 step evaluation procedure is followed. In the first step proposals are assessed by at least 2 external reviewers. The successful applicants are invited to present proposals at the meeting of the Committee for International Projects Evaluation (step 2). The project proposals will be evaluated on both sides according to the following criteria:

- Scientific and Technological Excellence
- Methodology
- Project Management
- Importance of International Collaboration
- Impact

Evaluation scores range from 1.0 to 6.0 for each criterion.

## 8. Selection and Funding Procedures, Feedback to Applicants

The mutual meeting of TÜBİTAK and SAS representatives is organised aiming to consensually select proposals and prepare final list of the projects recommended for funding on both sides. Final funding decision is made by the Presidency of TÜBİTAK and SAS Presidium respectively.

The selection and funding procedures followed by TÜBİTAK are explained in the [National Regulations Document](#).

Slovak coordinators, whose projects are recommended for funding, will be requested to submit the specific form (MVTs Form) ahead of final funding approval, which is subject of decision of SAS Presidium. Further details about processes are available [here](#).

At the SAS side, the anonymized external reviewers' reports without the scores and overall assessment of the Committee for International Projects Evaluation are provided to the applicants as feedback.

## 9. Projects Follow-up and Projects results

The projects will be monitored through progress and financial reports and the final report by both SAS and TÜBİTAK for its content and progress.

The Slovak PI of a funded project submits an annual progress report consisting of a scientific and a financial part. The final report is sent for a review to the International Projects Evaluation Committee.

The Turkish PI has to prepare financial and scientific/technical progress reports at determined dates according to the national regulations of TÜBİTAK.

Continuation of funding will be decided on the basis of this monitoring and is subject to the consent of both research funding organisations.

As the research projects will be carried out by multiple project partners, it is responsibility of the Principal Investigators to conclude cooperation agreement and provide it to the funding agencies, if requested.

It is expected that the agreement sets out internal arrangements between project partners, such as responsibilities and liabilities of the project partners, project governance, intellectual property rights, project results exploitation rights and other terms and conditions, which may be considered as relevant by parties.

Any publication of the project results must acknowledge the support received from the SAS and TÜBİTAK.
